### **APSTAR 6 SUSTAINS PARTIAL POWER LOSS AFFECTED SERVICES RESTORED BY APSTAR 6C**

The announcement is made by APT Satellite Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rule**”) and Part XIVA of the Securities and Futures Ordinance (Chapter 571) of the Laws of Hong Kong.

In the late evening of 27 May 2018, APSTAR 6 Satellite suffered partial power loss due to anomaly of south solar array. As a result, part of satellite transponders had to be turned off and related customer traffic were suspended. The Group has worked with satellite manufacturer to confirm the anomaly. Except this power anomaly, all the other satellite systems and satellite control function are in normal condition.

APSTAR 6C, which was launched successfully on 4 May 2018 and originally scheduled to replace APSTAR 6 in June this year, has been under in-orbital test. After the occurrence of the anomaly, APSTAR 6C has been drifted immediately to 134E orbital slot on 29 May 2018 and at present co-located with APSTAR 6. The affected services have been successfully restored via APSTAR 6C transponders from early hour in the morning of 30 May 2018.

The Board of Directors believe that the event will not impose real impact on the operation of the Group.
