SUCCESSFUL LAUNCH OF APSTAR 6D SATELLITE BY
LONG MARCH 3B/E LAUNCH VEHICLE TO
THE DESIGNATED ORBIT

The announcement is made by APT Satellite Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rule**”) and Part XIVA of the Securities and Futures Ordinance (Chapter 571) of the Laws of Hong Kong.

The Board of Directors is pleased to announce that APSTAR 6D Satellite was successfully launched to the designated geostationary transfer orbit on 9 July 2020 on board of Long March 3B/E launch vehicle. The APSTAR 6D Satellite is procured by APT Mobile SatCom Limited (“**APT Mobile**”), an associate of the Group in Mainland China, the satellite is based on DFH-4E platform.

Following the launch, multiple orbit raising operations will be conducted to put satellite into the geostationary orbit and the in-orbit test will be performed to ensure that the satellite’s performance conforms to the design specification.

APSTAR 6D Satellite is a high throughput satellite (“**HTS**”) and will provide coverage for Asia Pacific region, it is a first HTS satellite optimized for satellite broadband mobility services in the region, the satellite is equipped with high throughput multiple spot beams and other unique and advanced features to meet the market demand in China and the whole Asia Pacific region.
