This announcement is made by APT Satellite Holdings Limited (the "Company") pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the previous announcement of the Company dated 29 June 2017 (the "Announcement"). Capitalised terms used in this announcement shall bear the same meanings as those defined in the Announcement unless the context requires otherwise.

On 26 June 2017, APT HK received the Summons and Complaint filed by the Plaintiff in the Supreme Court of the State of New York, County of New York, in respect of an action for contributory trademark infringement and vicarious trademark infringement. The action was removed to a federal court, the United States District Court, Southern District of New York (the "Court") on 18 July 2017.

On 10 September 2018, APT HK's motion to dismiss the Plaintiff's complaint was granted by the Court for lack of personal jurisdiction. The Court determined that the Plaintiff failed to make the requisite prima facie showing that the Court may exercise personal jurisdiction over APT HK. Further, the Plaintiff's motion for jurisdictional discovery was denied by the Court. The Clerk of Court was directed to enter judgement dismissing the case for lack of personal jurisdiction and close the case.
